

A GUIDE TO COMMON SERVICES

To assist families in selecting the type of arrangements that best meet their needs, we have summarized the most common options that most families request. These are guidelines only, as we can accommodate other requests that may not be listed below. Please inquire with one of our directors.

A: Two Day Traditional Funeral: Available for Burial or Cremation

- Includes four hours of public visitation (open or closed casket with embalming) and up to one hour of private family visitation and/or set-up time the day prior to the service (usually 2-4 & 7-9 p.m.)
- Funeral service in the funeral home or church on the second day
- Includes Personalized Stationary Package and Funeral Coach
- Burial or cremation is held after the service is complete
- After Funeral Reception Facilities and Digital Photo Video Montage may be added
- \$4,690

B: One Day Traditional Funeral: Available for Burial or Cremation

- Includes one hour of public visitation and up to one hour of private family visitation and/or set-up time the same day as the service (open or closed casket with embalming)
- Funeral service in the funeral home or church on the same day
- Includes Personalized Stationary Package and Funeral Coach
- Burial or cremation is held after the service is complete
- After Funeral Reception Facilities and Digital Photo Video Montage may be added
- \$4,090

C: One Day Traditional - Ship In From Other Establishment

- Where a person has died at a location that required the services of another funeral establishment for legal registration, embalming and transportation
- Includes one hour of public visitation and up to one hour of private family visitation and/or set-up time the day prior to the service (casket not present)
- Includes casketing and final preparation (deducted if provided by other funeral establishment)
- Funeral service in the funeral home or church on the same day
- Includes Personalized Stationary Package
- Additional visitation (open or closed casket) on the day prior can be added to this option as required
- After Funeral Reception Facilities and Digital Photo Video Montage may be added
- Mileage from Pearson International Airport included
- Final price will be determined according to services provided by other funeral establishment

G: Simplified Disposition: Available for Burial or Cremation

- No visitation or viewing
- Memorial service or ceremony, if any, to be arranged and coordinated by the family

- Personalized Stationary Package and Digital Photo Video Montage may be added
- For a fee of \$100 (plus any applicable vehicle mileage) the funeral home can deliver the cremated remains to the cemetery where families do not wish to be in attendance

 - Embalming is the chemical preservation of the deceased. It is a process of sanitation, restoration and temporary preservation.
 - Embalming is not legally required, but may be recommended to preserve the body between the time of death and the visitation or disposition of the deceased.
 - Our professional funeral directors will make a recommendation based on the condition of the body and expected service needs. Certain services, such as open casket visitation for the public, may be refused if permission for embalming is not provided.
 - Delayed burials related to winter closure may also require embalming. Alternative options will be provided if permission for embalming is refused.
